We collect and hold information about you to enable us to run the charity and manage our projects efficiently and effectively. Footprints in the Community have a 'legitimate interest' to store and use your data in this way.

Most of the information we hold will have been provided by you, from your application or referral form and documents you sign or give to us. Some information may be provided by external sources, such as from agencies who are working with you. This information forms the basis of a confidential member/client record, which we may hold in both electronic and securely-stored paper format.

We keep your personal information as secure as possible and we do not share your information with any other agencies or companies, except as required by law.

The length of time we will hold your personal information for depends upon the nature of the data.

You have a number of rights, including: the right to see any information that we hold about you, to rectify any errors in the information we hold and to have your details removed.

You also have the right to complain to the Information Commissioner's Office if you feel that we have not complied with the requirements of the General Data Protection Regulation.

Using Next Step Shop

These are some things you need to agree to before you can use the shop:

- You can only be a member of either Redcar or Grangetown Next Step Shop at any one time.
- You can visit the shop where you are a member once each week, for up to 6 months.
- After 6 months you will be asked to attend an assessment meeting with our Advice & Support Worker
- You pay **£3.50** each time you use the shop.
- You must bring your membership card with you every time you shop.
- Only one person in your house can be a member at any one time.
- You can choose 10 items of food each visit.
- You must be referred to the shop by an agency that you are working with and they must sign and date the application form.
- We may cancel or refuse your membership, for example, if you do not use the shop for four weeks, you move away from the area, or you abuse the shop or our volunteers.
- If we cancel your membership because you have not used the shop, you can apply again, but you will be placed at the end of a waiting list.
- We will usually limit the number of members. Once our membership is full, we will place any new applicants on our waiting list.
- Some food items may not always be available and we may limit some items to one or two per member. You cannot pre-order items.
- If you have special dietary requirements or allergies, it is your responsibility to check food packaging.
